The following are important dates and policy information.

- The Studio will be closed Nov. 21-28, 2010 for Thanksgiving; Dec. 19, 2010 - Jan. 2, 2011 for Winter Break; and March 20-27, 2011 for Spring Break. Classes will be held on Labor Day, Sep. 6, 2010; Columbus Day, Oct. 11, 2010; MLK Day, Jan. 17, 2011; President's Day, Feb. 21, 2011; & Memorial Day, May 30, 2011.
- Dance Recital dates will tentatively be May 21, 2011, for younger dancers and June 4, 2011, for all other dancers.
- Statements will be sent (via email) during Week 6 of each session, and tuition is due by the end of Week 7. If tuition is not received by Week 8, a \$10 late charge will be added to your account and your child's spot may be forfeited.
- There are four 8-week sessions and one 6-week session in the 2010/2011 schedule. Each student is automatically enrolled for the next session unless the Studio has been informed of the student's request to drop. In order to drop a class without incurring additional tuition charges, your student must turn in a drop form by the 7th week of the current session.
- No credits, refunds, or make-ups are given for classes missed due to holiday, vacation, or weather. If your student misses gym class due to illness, he/she can attend the make-up class offered on the 7th Saturday of each 8-week session. (Students must sign up for this make-up class.) If your student misses a dance class due to illness, please inquire with that class teacher.
- During inclement weather, please check www.thesundancestudio.com or call the Studio for the recorded message. As a rule: If District 38 schools close, the Studio will also close; however, we may reopen later in the day if weather improves. Please check the recording one-half hour before your student's scheduled class time. If more than three Studio closures occur on the same class day during the school year, the Studio will schedule a make-up.
- There are no refunds/credits given if your student drops a class after the session has started.
- Dress Code: Hair pulled back from face; Do not wear dance shoes outside; Girls, leotards/tights; Boys, sport shorts/T-shirt; Black tap shoes for boys and girls; Pink ballet shoes for girls and black for boys; Black jazz shoes; Lyrical shoes may vary by class and will be determined by the class instructor.
